**SELECT BOARD / TOWN MANAGER**- The town has been working with FEMA to seek reimbursement for some of the town-owned properties damaged in the January 10 storm. A site inspection was conducted by FEMA on June 25th. Director of Emergency Management, Jackie Johnston, has been spearheading this effort supported by Selectman Bob Harmon and town employees Mike Pinkham and Mike Connors. Many thanks to these individuals as they navigate the federal requirements in this process.

The town is considering putting together a buildings and grounds committee to examine town-owned properties. Tax Liens were delivered to the Hancock Registry of Deeds on June 28th. These liens were applied to all delinquent real estate accounts that have not been paid for the 2023 tax year.

Tax bills will be sent out late August / early September. If you do not receive a bill by the end of September, please call the Town Office to request your bill. We only send out <u>ONE</u> tax bill that includes two coupons at the bottom of the bill. The first half payment is due October 31, 2024 and the second half is due March 31, 2025. You can make weekly or monthly payments as well. Please be aware, we are not required by the State of Maine to send tax bills. This will walk you through the steps and will be applied to your tax account. Please keep in mind there is a 2.5% charge fee for debit / credit cards. This is the same fee that is charged when payments are made in person or over the phone with cards.

**MOORING PERMITS**- Please be aware, <u>ALL</u> mooring fees are due by July 1<sup>st</sup> and can be paid until August 30<sup>th</sup> without penalty. Starting September 1<sup>st</sup>, a late fee of \$25 will be added to all outstanding fees which is half of the regular mooring fee. Please come to the Town Office to pay these fees.

**THE SEABREEZE SOCIETY AND COREA GRANGE**- The Seabreeze Society and Corea Grange Annual Rummage Sale will be held Saturday, July 13<sup>th</sup> from 9AM to Noon at the 64 Crowley Island Hall in Corea. Inside will be the traditional Down East Bake Sale, treasures, contents of a Corea home, and finer clothing. GOULDSBORO HISTORICAL SOCIETY- July's program will be held July 1, 2024 starting at 7PM at the Prospect Harbor Women's Club. Speaker, Tom Testa, will tell the story of how the railroad came to the Downeast coast in the 1880s, totally transforming the way our alongshore communities lived and worked. Beginning with the building of the Maine Shore Line Railroad in 1884 from Brewer via Ellsworth to the Hancock peninsula, the new railroad allowed quick access by ferry to a rapidly expanding tourist economy in the Bar Harbor region. Soon afterward the rail line expanded eastward to become part of the Calais Branch of the Maine Central Railroad in 1911, serving the entire Washington County shore. Though the original system has faded, some of it still lives on in the equipment in active use in the Downeast Scenic Railroad in Ellsworth. Our speaker Tom Testa is a founding member and President of the Downeast Rail Heritage Preservation Trust which operates the Downeast Scenic Railroad.

The presentation is one of a series of seasonal programs organized by the Historical Society. August 5<sup>th</sup>, "September Sunshine and Shadow; Maine Painted in Words," by Rev Charles A. Joy, GHS historian. September 9<sup>th</sup>, "Voting Down the Rose; Florence Brooks Whitehouse and Maine's Fight for Woman Suffrage" by historian Anne Gass. October 7<sup>th</sup>, "Songs of the Downeast Rivers and Seashore" by Ann and Stephen Sanfilippo.

**SCHOODIC FOOD PANTRY**- They're Ba-ack! The Carol Bailey String Band, that lively group of some 25 seniors led by Pat and Jon Bailey, will return to the Prospect Harbor Women's Club on Wednesday, July 17th, for a noontime concert to benefit the Schoodic Food Pantry's Building Fund. Playing guitars, ukuleles, mandolins, cello, banjo, bass, recorders, harps, harmonicas, and percussion instruments, the singers will do a program called "All About Maine, "which features songs by Maine songwriters, including our own Rick Barter and his beautiful "Acadia Waltz."
