Versant is not going to back charge for these lights but would like to know if the town would like to keep the two lights and start paying the bill or they can remove the lights. The Select Board would like to keep the lights as it is necessary.

Anne Sterling, a new resident to Gouldsboro, asked if the town has a dark sky light pollution ordinance? Bill Zoellick answered and mentioned when he was on the Planning Board the Board approved to enforce this matter in our town ordinance.
